- 5. A motion was made to approve the minutes of 6/10/23, 8/14/23, 8/19/23, and 8/24/23. 1st-E. Weeks, 2nd-C. Enright. Motion passed unanimously.
- 6. **Secretary Report**-R. Tavitian-All correspondence and minutes are up to date. Approved minutes are on our website. A DR mentioned that our 9/23/23 meeting occurs during a holiday weekend and asked for it to be changed. After discussion, it could not be moved without causing other issues.
- 7. **Treasurer Report**-B. Gregorio-The financial reports were discussed. The balance sheets, profit and loss statements, and the 2023 budget were emailed and discussed. A motion to receive the financial reports was made. 1st-C. Enright, 2nd-P. Guadagnino. Motion passed unanimously.

There were issues with waiver requests and departments are always encouraged to hire new personnel to fill positions. A new availability form is being piloted and will be used in the future.
- 10. **President Report**-S. Krompier-Negotiations are moving slowly. We do not endorse candidates running for office but will solicit letters from all factions and publish them in the Vanguard. S. Stark was thanked for the work he does with waivers and communicating with departments. The meeting following the RA/EB meeting went well and issues were resolved favorably. If anyone has any issue, S. Krompier should be contacted directly. Dual enrollment was discussed and will have a positive effect on adjunct assignments. The delayed retro pay for non-classroom faculty was brought to the administration and they contacted the county. We hope for a speedy resolution.
