The Inside Scoop

In his column, our VP Scott Stark noted that the Nassau County legislature approved our Collective Bargaining Agreement (CBA). Our CBA has also been signed by our County Executive, Bruce Blakeman, fully executing the agreement. From the wage standpoint, this agreement raises all adjunct wages by 3% for the period September 1, 2023 – August 31, 2024. On top of that wage increase, there was an additional 3% for the period September 1, 2024 – August 31, 2025, and a 2.75% wage increase for the period September 1, 2025 – August 31, 2026. The

retroactive payments will take months to be calculated as the County must identify who worked and for how many hours in order to calculate retroactive wages due. The new CBA will be in electronic form and will be emailed to all members when it becomes available. This process will also take some time since the language must be reviewed meticulously to make sure it reflects what we agreed upon. Moreover, a missing comma or punctuation mark could cause the meaning of a section to change.

I would be remiss if I didn't address the uncertainty of so many things happening on campus. Uncertainty gives birth to stress and anxiety. I will focus on two areas that comprise a large part of the uncertainty: Declining enrollment and department mergers. We have witnessed a steady decline in enrollment for many years. This decline is bad for the College and bad for our members since fewer assignments are available. The AFA continues to make recommendations to the College on initiatives that could increase enrollment and aid in retention. We understand a robust enrollment will benefit our members with increased assignments. To that end, we will continue to make recommendations on how best to increase enrollment. The other big uncertainty is department mergers. As of August 1, 2024,

mergers have been enacted. Under the AFA jurisdiction, there was little that we could do regarding the College's desire to make these mergers. However, as a union there was much that we could do to maintain your same level of representation. The AFA leadership along with the AFA Executive Board made recommendations to change our Constitution so that your representation would not suffer. Those changes were overwhelmingly approved by the membership. As a result, you can still

speak to the same representative that you went to prior to the mergers. You will find a listing in the front of the Vanguard showing all the original departments along with the AFA contact person for each of those departments.

In closing, we as a union have navigated through troubled waters and difficult times, and we will do so again. In the face of these uncertain times, we can find solace in knowing that we are a large, united union. When we stand together, we stand strong. You can rest assured that whether we are fighting for a large contingent of our members or to protect the position of a single member, we will be there for you. I want to extend my appreciation to all of you for all you do for our students and for your support of the AFA. You, collectively, are the heart and soul of the AFA.
